### Application for enrolment fee

### Confirmation of enrolment fee

There is a once-only fee payable when the College notifies a family that their son's application for enrolment has been accepted. This fee applies to all scholastic years and is non-refundable. Where three or more boys from the same family are being accepted at the same time, *Confirmation of enrolment fees* are capped.

### Senior studies' deposit

For Year 11 students there is an additional deposit which is not an extra charge but is credited to the fees payable by parents for the final term of Year 12. This fee is non-refundable if a student does not commence enrolment or leaves school before the end of Term 4, Year 12.

## Enrolments during the year

New enrolments arriving at the College at times other than the start of the academic year will be required to arrange payment of their school fees prior to the current school term.
